Tax Data On-Line consists of TRDB, RTFOL, RPVOL, DDB, NAP and SCAP/SCOP systems.
- (2) **Purpose:** This transmits revised IRM 2.3.57, IDRS Terminal Responses, Command Code BRTVU.
- (3) **Audience:** Tax Analysts, Research Analysts, Auditors, and Fraud Detection Analysts in LMSB, SBSE, TEGE, Appeals, TAS, CI, IT, and TS.
- (4) **Policy Owner:** Chief Information Officer, Kaschit Pandya.
- (5) **Program Owner:** Information Technology/Applications Development.

This system/application provides the following functionality:- legislative changes to the tax law as reflected in the form filed;- modifications to data elements as required by the IRS business units;- maintaining the interface for online access.- Online access to Return Preparer Inventory.

- (3) Duplicate TIN Online (DUP TIN) provides on-line access to the Duplicate TIN Database. It provides information on duplicate uses of an individual's TIN. It maintains a record of how each SSN was used on a 1040 return (primary, secondary, and dependent).
- (4) (1) Programs are managed in Endeavor.
- (5) (2) Change Tickets are required for program changes and are managed in IRWorks/Service Now.

The BRTF files store data for posted business forms 11C, 706, 706GS, 709, 709-NA, 990, 990-T, 990EZ, 1120's, 8038's, 1041, 730, 940, 940EZ, 941, 943, 944, 945, 1042, 1065, 1066, 1139, 2290, 3520, 4720, 5227, 5330, 8288, 8328, 8804, CT-1.
- (2) IRM 2.3.57 In PY 2025, the definer code S4, S5 was added to the new form 4255 that is now attached to the forms 1120 form family, 1065, 1041, 1041-QFT and the 990T.

### Command Code (CC) BRTVU General

- (1) The Input screen for Command Code BRTVU is displayed in Exhibit 2.3.57-1
- (2) BRTVU summary screens display associated returns/schedules/forms submitted by a specific filer.
- (3) The command definer on the screen allows users to view the forms and schedules associated with the tax return. If there is more than one page in a form, there will be more than one command definer associated with the form. The command definers are found on the summary screen.
- (4) Command code BRTVU allows the user to directly access a page by using the command definer code. The user can enter the TIN, MFT, tax period and definer code to directly access the page that the user wants to query.
- (5) BRTVU is a research command code. The data cannot be adjusted or changed.

### Command Code BRTVU Terminal Responses

- (1) RECORD NOT FOUND —A request was made for which there is no information on BRTF. If a return is over 3 years old, it will not be displayed on BRTVU.

- (2) REQUEST CAN NOT BE SERVICED AT THIS TIME, TRY AGAIN LATER—The portion of the BRTF file where this form resides is not available for on-line BRTVU access. This may be due to routine daily maintenance (e.g., loading new returns). Report this error message to your user support area if it occurs outside of the maintenance window of 2400 - 0600 ET.
- (3) FILE ERROR CODE XX ON RTF FILE YYZZ XXXXXX, CONTACT IDRS TECHNICIAN—The BRTF VSAM files are not available for on-line BRTVU access. Report this error message to your user support area. - (4) FILE ERROR CODE XX ON RTF ACCRETION FILE YYZZ XXXXXX, CONTACT IDRS TECHNICIAN—The BRTF VSAM files are not available for on-line BRTVU access. Report this error message to your user support area. The problem should be brought to the attention of Enterprise Computing Center-Martinsburg (ECC-MTB) via ITAMS.
- (5) YOU ARE NOT AUTHORIZED TO ACCESS THIS PROGRAM—You do not have access to BRTVU. Report this message to your Supervisor and request access.
- (6) INVALID REQUEST — CHECK INPUT—Check the format of the command request.
- (7) THE TIN FIELD IS INVALID — CHECK INPUT—Check the format of the SSN.
- (8) THE MFT IS NOT VALID - CHECK INPUT— The MFT entered is not valid for BRTVU.
- (9) THE TAX PERIOD MUST BE NUMERIC - CHECK INPUT— Check the format of the Tax Period.
- (10) THE TAX PERIOD FIELD IS IN ERROR - CHECK INPUT—Check the format of the Tax Period.
- (11) THE FORMS REQUESTED ARE NOT AVAILABLE—The MFT and/or DOC-CD entered are not valid.
