Subject: Transmitting returns for Authorized IRS e-File Providers

ATTN: Transmitters

As a reminder, Transmitters must ensure they are only transmitting returns for Authorized IRS e-File Providers with an Electronic Filing Identification Number (EFIN) belonging to the e-file Provider. Transmitters can request information from the Authorized IRS e-File Provider to prove the EFIN is active and belongs to the Provider.

Transmitters who fail to validate the EFIN belonging to the Provider, may be subject to sanctions and the inability to transmit.
