GENERAL BUSINESS PURPOSE

What is the general business purpose of this system? Provide a clear, concise description of the system, application or database, the reason for the system, and the benefits to the IRS to use the information, and how the information will be used.

View Debit automates allowing qualified callers to hear a verbal review of an individual filer's master file account. On demand, processes requests sent by the Voice Response System (VRS) to query Integrated Data Retrieval System (IDRS) to determine if the taxpayer is eligible to receive account information via the automated system. If the taxpayer is not eligible, a route code defining the reason for denial will be sent. If eligible, the function will return to the VRS information on the tax modules available and whether or not each module has a balance due.

View Debit requires the use of SSN's because no other identifier can be used to uniquely identify a taxpayer. SSNs are permissible from Internal Revenue Code (IRC) 6109, which requires individual taxpayers to include their SSNs on their income tax returns.

Describe the planned mitigation strategy and forecasted implementation date to mitigate or eliminate the use of SSN's (or tax identification numbers).

The Office of Management and Budget Circular A-130 requires that federal agencies develop a mitigation or elimination strategy for systems that use SSNs, which the Service continues to develop strategies to meet. An exception to that requirement is when the SSN is uniquely needed to identify a user's record. View Debit requires the use of SSNs because no other identifier can be used to uniquely identify a taxpayer at this time.

The PII items above are collected from the taxpayer to authenticate them prior to providing them with tax related information. This information represents the least amount of data needed to authenticate the individual, identify possible ID theft without any more information on user as possible using existing IRS command codes.

How is the SBU/PII verified for accuracy, timeliness, and completion?

Accuracy: Authentication must include data in a prescribed format and must meet a variety of validation criteria that ensure proper validation to the appropriate account. Taxpayers are authenticated to check payments status on the IRS's Master Files before status information is returned to them. The app simply takes the SSN entered by the taxpayer and checks for it in the database; if it is found, they are required to enter a PIN which is then checked against the PIN connected to that SSN. If it's a match, they are granted access to that account's data.
Timeliness: The system notifies the taxpayer with the date a payment has been received.

View Debit does not directly provide individuals the opportunity to decline from providing information and/or from consenting to particular uses of the information. Notice, consent, and due process are provided via the IRS systems and their related tax forms instructions, and pursuant to 5 USC. Published System of Records Notice in the Federal Register. The IRS has the legal right to ask for information per IRC sections 6001, 6011, and 6012(a), and their regulations. The regulations state that "taxpayers must file a return or statement with IRS for any tax they are liable for". Their response is mandatory under these sections. The taxpayers failing to provide the required information renders them ineligible to use the system.

View Debit uses the Integrated Customer Communication Environment (ICCE) capability to capture audit data and forward the data to an Enterprise Logging System - Security Audit and Analysis System (SAAS). ICCE does not store audit data. Instead, audit records are created in memory and sent to SAAS as "forward and forget". There is no ability to access the audit information from the application or from the server on which the application runs.
